#### **Background:**

Section 381.80 of Amended Substitute House Bill 33 of the 135<sup>th</sup> General Assembly appropriated funds to award grants under the Teach CS Grant Program established in Ohio Revised Code Section 3333.129. ODHE released a Request for Applications ("RFA") on November 1, 2023 seeking colleges and universities and educational service centers who desired to partner with ODHE to increase the number of teachers qualified to teach computer science in Ohio. 11 colleges and universities and five ESCs were selected to receive a Teach CS grant. ODHE now seeks to allocate the remaining 1.9 million dollars to existing partners who can demonstrate need and new partners that will operate in underserved geographic locations. This RFA is for new educational service center and college/university partners.

Consistent with ORC Section 3333.129, funds may only be used for expenses including coursework, materials, exams and exam preparation, and computer science continuing education. Continuing education is eligible for funding where the teacher is currently qualified to teach computer science under Ohio law. This includes teachers currently qualified to teach computer science by virtue of compliance with section 610.120 of HB33 as described below, as well as teachers who can demonstrate it is the intent of their district for them to complete the continuing education to teach computer science pursuant to section 610.120 of HB 33.

Proposed costs to be covered under any grant award must be consistent with historical market rates for the same or similar services. Professional development programs should align to Ohio's current learning standards for computer science education.

#### **Eligibility:**

This RFA is open to Ohio educational service centers and state universities as defined in section 3345.011 of the Revised Code and non-profit private institutions of higher education with a Certificate of Authorization issued pursuant to Chapter 1713 of the Ohio Revised Code with Chancellor-approved educator preparation programs and Chancellor-approved computer science endorsements.

Applicants must demonstrate how they can help accomplish the goal of increasing the number of teachers licensed to teach computer science through any of the following:

- computer science endorsement,
- a supplemental license, or
- alternative resident educator license

Applicants must demonstrate that the area of the state in which they seek to operate is underserved by current Teach CS grants. A list of the current grants can be found at <a href="https://highereed.ohio.gov/teachcs">https://highereed.ohio.gov/teachcs</a>

## **Anticipated Awards:**

The Ohio Department of Higher Education has approximately 1.9M remaining in the Teach CS appropriation for FY 2025. ODHE seeks to provide additional Teach CS grant funding to new educational service center partners and colleges and universities in underserved areas of the state. ODHE will also be releasing an RFA for existing partners simultaneous to this RFA. Both RFAs are allocating the same 1.9M in funding.

#### **Project Term:**

The project term will begin on July 1, 2025 or upon execution of an award agreement with ODHE, whichever date is later and end June 30, 2025. Chosen awardees must enter into an award agreement with the Ohio Department of Higher Education to receive the funds.

#### **Award Recommendations:**

The Chancellor shall make the final determination regarding which applications, if any, receive an award.

Applicants are responsible for timely submissions of applications. Applications become property of ODHE and are subject to public record laws of the state. Applications containing all the required elements will receive careful consideration but cannot be guaranteed funding. Accepted applications will be evaluated and the Chancellor will make final decisions based upon the quality of the application in addressing the application criteria and its required elements. There is no set number of awards.

Funds will be made available to awardees after July 1, 2025 and execution of an award amendment with ODHE.

#### **Criteria Descriptions:**

# Project Plan:

- a. Provide a rationale for the project and describe the licensure pathway or combination of pathways to be funded.
- b. Outline the plan for program management including roles and responsibilities of key personnel.

c. Address the plan for recruiting and retaining students through completion of the pathways described above.

#### **Project Metrics:**

- a. The number of teachers you currently have enrolled in CS programs, if applicable.
- b. The number of teachers you expect to recruit into the licensure pathway(s) described in Project Plan a.
- c. Explanation of why the area you seek to serve is underserved by the current Teach CS grants.

## **Budget Narrative:**

- a. Amounts for each budget line activity are documented and justified in the budget narrative.
- b. The narrative should include an estimate as to the timing of expenditures in relation to the project plan.

#### **Reporting Requirements:**

Successful grant awardees will be required to submit expense reports, program reports, and participant reports on a schedule determined by the ODHE.

ODHE anticipates utilizing semiannual reporting periods that could follow this schedule:

- Summer/Fall Reporting Period: July 1st to December 31st with reports due February 15th
- Spring/Summer Reporting Period: January 1st to June 30th with reports due August 15th

Expense reports should include a list of all expenditures made with funding from the grant as well as coding for what type of eligible expenditure it is (coursework, materials or exams). A reporting template will be provided to each awardee.

Program reports will be required from all awardees describing the number of enrolled students, student success metrics, completion rates by program (endorsement licenses, supplemental licenses, alternative resident educator licenses, and continuing education).

ODHE will monitor each grant recipient institution to ensure that there is fiscal accountability and operating progress, and that the desired outcomes are achieved.

Participant reports will be required from all awardees providing secure access to unique identifiers for participating teachers or prospective teachers to verify program outcomes such as completions, licensure, to verify qualifying expenses paid, and to facilitate program audits when needed. A secure method for transmitting this data will be provided to each awardee.

ODHE may utilize the Higher Education Information (HEI) system to track student progress as well as the EMIS (Education Management Information System) operated by the Ohio Department of Education and Workforce to provide longitudinal data on which schools teachers are teaching at and what courses they are teaching following the grants.

Private non-profit colleges and universities who choose to participate in the grant program have agreed to submit data to the department sufficient to provide comparable program success tracking. All award expenditures must be properly documented following Ohio Revised Code and Administrative rules.

## **Legal Notices:**

The applicant understands that if its application is accepted by the State, the applicant shall enter into an agreement amendment with the State governing the use of the awarded funds. The applicant agrees to comply with all applicable federal, state, and local laws and regulations in the conduct of the work hereunder.
