# Request for Applications Competitive Grants for Teacher Credentialing

#### October 2024

The Ohio Department of Education and Workforce, in consultation with the Ohio Department of Higher Education, is requesting applications for competitive grants for its College Credit Plus Teacher Credentialing Grant program. In accordance with Section 265.120(A) of Am. Sub. H.B. No. 33 (135<sup>th</sup> G.A.), the purpose of the grant program is to award funds that will support high school teachers pursuing graduate coursework to meet the qualifications to teach college courses in a high school setting for the College Credit Plus program.

The awarding of the funds (up to \$3,000,000 in total grants) will be based on need, merit of proposal, and the applicant's ability to collaborate and develop strategies that will decrease gaps in qualified College Credit Plus instructors. The funds are to support graduate coursework for high school teachers to meet the required qualifications to teach College Credit Plus courses. Priority will be given to educational consortia that include economically disadvantaged high schools where there are limited or no teachers currently credentialed to teach College Credit Plus courses and a public or private college or university in Ohio.

The intent of the program is to establish programs through which instructors from many high schools can have access to efficient credentialing programming. Larger consortia provide more opportunity for consolidating expenses and expertise in developing credentialing pathways and infrastructure through which instructors can become credentialed teachers. Priority will be given to programs that innovate to provide credentialing in efficient and convenient ways to instructors (for example, summer bootcamps, flexible scheduling, and online coursework). Programs offering standard coursework to teachers should consider how they can make that coursework more intentionally designed for high school teachers to access the coursework in innovative ways.

## **Eligible Entities**

The following entities are eligible to apply for teacher credentialing grants:

- School districts established under Ohio Revised Code 3311;
- Community schools established under Ohio Revised Code 3314;
- STEM schools established under Ohio Revised Code 3326;
- Joint vocational school districts;
- State institutions of higher education, as defined in Ohio Revised Code 3345.011;
- Private nonprofit institutions in this state holding a certificate of authorization pursuant to Ohio Revised Code 1713;
- Chartered nonpublic schools, as defined in Ohio Administrative Code 3301-39-01, that have been issued a charter in accordance with Ohio Revised Code 3301.16 and Ohio Administrative Code Chapter 3301-39; or
- Educational service centers or nonprofit entities in which education is the primary mission and is under a contract with any of the entities outlined above.



A single entity may be the sole applicant for a Teacher Credentialing Grant. Priority will be given to educational consortia that include economically disadvantaged high schools in which there are limited or no teachers currently credentialed to teach College Credit Plus courses. Consortia are defined as educational partnerships and regional collaborations and are comprised of more than one eligible entity. If a single entity is also prioritizing economically disadvantaged high schools (such as a large school district or community school network), they can receive the same priority.

Consortia applicants must identify a lead applicant, fiscal agent, and partner institutions or entities.

# **Priority Districts and Schools**

The Ohio Department of Education and Workforce, in consultation with the Ohio Department of Higher Education has identified priority districts and schools for applicants of this grant. In cases where a district is included in the list, each high school within the district would be considered a priority high school. There are three tiers of priority based on data for each district. Applicants that are or show collaboration with a priority district or school will be awarded priority scoring in the application process. Collaboration with one or more district in Priority Tier 1 will be awarded 10 points of priority. Collaboration with one or more district or school in Priority Tier 2 will be awarded 5 points of priority. A list of priority districts can be found in Appendix B. The priority tiers were established by looking at all advanced standing coursework taken in that district and establishing schools with low College Credit Plus participation (below 16%) and overall low to average participation in all other advanced standing coursework (below 16%, up to 41% on average).

## Awards

The Ohio Department of Education and Workforce reserves the right to award an amount that is less than or greater than the amount requested by any applicant. The total amount of all awards cannot exceed the total funding available. Funds awarded may only be used to support the direct costs of supporting graduate coursework for high school teachers to receive credentialing to teach College Credit Plus courses in a high school setting and for award-related expenses.

Total funding available is \$3,000,000. Eligible applicants should indicate an award amount requested. There is no limit to award amount requests but should be reflective of the expected number of high school teachers served.

All grant applications and proposal materials must be submitted online through the Ohio Department of Higher Education's RFP Portal at <u>rfp.ohiohighered.gov</u>. Documents may be uploaded and submitted through the RFP Portal in portable document format (PDF). No additional file formats are accepted. No hard copies of applications or proposal materials will be accepted.

All costs incurred in the preparation of a proposal shall be borne by the respondents and are not recoverable under an award. The decisions of the Ohio Department of Education and Workforce are final. Respondents will be notified of the outcome of their proposals at the conclusion of the review process.

## CONFIDENTIAL, PROPRIETARY AND TRADE SECRET INFORMATION

The Ohio Department of Education and Workforce solicits information through this request for applications in a transparent manner and in accordance with the laws of the State of Ohio. All responses provided to the Ohio Department of Education and Workforce become records of the Department and, as such, will be open to inspection by the public after award unless exempt from disclosure under law. If an applicant believes information in its proposal is a trade secret, as defined in ORC § 1333.61, the information must be marked as



such by underlining the information and notating it with asterisks. Because the applicant is in a better position to know which information may be a trade secret, the applicant's marking of such information will aid the Ohio Department of Education and Workforce in its review of the documents when responding to a request for public records under Ohio law. The Ohio Department of Education and Workforce has the sole discretion in redacting information in response to public records requests pursuant to ORC § 149.43.

### **RESERVATION OF RIGHTS**

The Ohio Department of Education and Workforce reserves the right to:

- Request or use additional information to assist in the review process;
- Require new proposals from interested parties;
- Reject any or all proposals responding to this Request for Applications;
- Re-issue, modify, withdraw, or cancel the Request for Applications at any time if it is determined that it is in the best interests of the entities and/or the state;
- Adjust any of the scheduled dates for this process for whatever reasons are deemed appropriate;
- Disqualify any application for failure to conform to the requirements of the Request for Applications;

# **Requirements for Awarded Grantees**

#### **AWARD NOTIFICATION**

Awarded applicants will be notified in January 2025 for the approved College Credit Plus Teacher Credentialing Grant activities funded under this request for proposal.

Upon applicant approval, the Ohio Department of Education and Workforce and Ohio Department of Higher Education will provide an award letter to the applicant's fiscal agent, which will include the total awarded. Grantees will be required to review and submit grant assurances in order to begin the project.

Awarded lead applicants will be required to log in to and upload the budget information within the Ohio Department of Education and Workforce's CCIP site. Additionally, lead applicants will be required to review and electronically complete the grant agreement and assurances within the CCIP system.



#### **REPORTING BY SEMESTER**

Each awarded applicant will be required to file progress reports near the end of each semester to the Ohio Department of Education and Workforce and Ohio Department of Higher Education in the CCIP system. This information will include the following elements and is subject to change at any time to provide further data and metrics to determine progress and impact:

An update stating and explaining whether or not the selected applicant is on track to meeting anticipated or projected outcomes. The number of candidates during the reporting period that:

- Have started a graduate program of study;
- Have started, but withdrew from a graduate program of study;
- Are anticipated to complete their credentialing requirement or graduate program of study; and
- Additional supporting data or information as needed.

#### **GRANT REIMBURSEMENTS AND REPORTS**

The Teacher Credentialing Grant will operate on a reimbursement basis. Grant expenses will be reported via a Project Cash Request (PCR) in the CCIP system at the time of submission of the semester reports. Anticipated deadlines for semester reports and PCRs are:

A Final Expenditure Report (FER) will be due after the end of each fiscal year by Sept. 30. These funds are available until June 30,2029. Carryover of funds into FY26 and beyond will be as needed.

- **Prompt 4** What is the proposal's plan for supporting College Credit Plus opportunities for students during the teacher credentialing period? This response is limited to 1,000 characters.
- Prompt 5 Describe the communication or recruitment plan the applicant and partners will use to inform teachers of the opportunity to earn graduate credit; 2) accelerate the application or selection process into the graduate course or program; and 3) retain teachers during the grant period to complete the necessary coursework leading to potential adjunct approval. This response is limited to 1,500 characters.
- **Prompt 6** What is the proposal's plan for sustaining College Credit Plus opportunities for students beyond the funding period? This response is limited to 1,000 characters.
- Prompt 7 How will the grant applicant increase the likelihood of success for teachers, after they complete the graduate coursework, to be approved by an institution to teach college courses in a high school setting? For this prompt, applicants (with a lead applicant that will not be the credentialing institution of higher education) shall upload a letter from an institution of higher education indicating that the institution would approve teachers who take specific courses in the proposal. If more than one letter is obtained, combine all into a single document to upload. This response is limited to 1,000 characters and one uploaded document.
- **Prompt 8** How will the grant applicant increase the likelihood of success for teachers to complete the graduate coursework by reducing barriers?
- **Prompt 9** What is the plan for retaining credentialed high school teachers or adjuncts in the school or district? This response is limited to 1,000 characters.
- **Prompt 10** What strategies will be used to promote innovation in programming for teachers? This response is limited to 1,000 characters.
- **Prompt 11** Provide the narrative description of the budget for the proposed model. (Also complete the *Budget* section within the *Application Form*.) This response is limited to 1,000 characters.
- **Prompt 12** What additional information do you want to share that has not been addressed within one of the other prompts or can expand upon other prompts? This response is limited to 1,000 characters.



#### Application Part III. Budget Section

Complete the Budget sheet included in the ODHE RFA Portal for the total grant amount requested.

Indicate the total amounts for each object code that are proposed to be used. Allowable expenses include graduate coursework tuition, fees, textbooks, and materials for the high school teachers participating in the program. Additional allowable expenses may include costs associated with employing teachers who are currently credentialed to teach college courses as a bridging strategy until a sufficient number of teachers at the high school hold the required credentials.

#### Appendix A:

#### State Law Reference: House Bill 33 (135th G.A.) Section 265.120

"Of the foregoing appropriation item 200448, Educator Preparation, up to \$3,000,000 in each fiscal year shall be used by the Department of Education and Workforce, in consultation with the Department of Higher Education, to provide awards to support graduate coursework for high school teachers to receive credentialing to teach College Credit Plus courses in a high school setting.

The Department of Education and Workforce, in consultation with the Department of Higher Education, shall develop an application process and Am. Sub. H. B. No. 33 135<sup>th</sup> G.A. 5859 criteria for awards. Priority shall be given to education consortia that include high schools identified as economically disadvantaged in which there are no or limited numbers of teachers currently credentialed to teach College Credit Plus courses, as determined by the Department of Education and Workforce, and a public or private college or university in Ohio. Awards made by the Department of Education and Workforce may support graduate coursework for high school teachers at a public or private college or university in Ohio leading to credentialing to teach college courses. Upon the request of the Director of Education and Workforce and the approval of the Director of Budget and Management, an amount equal to the unexpended, unencumbered balance of the amount allocated in this division at the end of fiscal year 2024 is hereby reappropriated for the same purpose in fiscal year 2025."

To maximize the impact of the grant, three priority tiers were established to help open College Credit Plus courses with credentialed high school teachers at schools where there is little opportunity for all forms of advanced standing coursework. The criteria for the priority tiers are as follows:
